Key Highlights/Issues

1. Highlights from the workstream on Donor coordination for food systems transformation (High-Level dialogue and draft paper) + Q&A

PURPOSE OF SECTION:

Jim Woodhill, Senior Advisor to the Platform, and Monique Amar, Platform consultant, gave an overview of the 27 June event.

ISSUES DISCUSSED:

- High-level participation during this event included a Minister, Senior representatives from international organizations and donor countries. There were 50 people online throughout the day and approximately 20 in person.
- Some of the key takeaways from this event include:
 - Widespread agreement that coordination is more important than ever, and all development actors need to do better.
 - We are in a fundamentally different environment than in the past, the urgencies that we see now are multiplying and overlapping and give us an opportunity to change and innovate approaches for coordination and collaboration.
 - Data are critically important, in terms of collection and usage.
 - There are areas where donors have completely different priorities, and areas where incompatibilities between donors and governments might make collaboration complicated.
 - It was proposed for the Platform to continue conversations further and showcase good examples of country-level donor coordination. [Jim Woodhill]
 - Incentives for enhanced collaboration were also discussed. The risks of not coordinating are much greater than the risks of simply disagreeing on these issues. [Monique Amar]
 - The importance of a proper and articulated negotiation process was recognized, particularly at the country level. Donors have their own political priorities, and an honest conversation about what is feasible in terms of country-level coordination should take place.
- As geopolitics are making coordination increasingly difficult, donors must engage with other actors (e.g., the private sector) at country and global levels. Some Board members asked whether the GDPRD could potentially act as a facilitator between various actors.
- During the event, a critical point was raised on donors' alignment with the Aid Effectiveness agenda. Over the last years, donors' engagement has witnessed increased fragmentation, which sometimes translated also into "competition" at the country-level. For example, the "Team Europe" mentality of European at country level could be a helpful tool to get inspiration from, in improving coordination. [Ireland, France]
- Examples of good coordination in other sectors (e.g., health, education) could be explored for replication in food systems. However, incentives for coordination are still a critical issue. *[France]*

- The food systems transformation pathways are tangible, authoritative reference points for donors to engage in country-level coordination.
- The discussion on accountability to taxpayers in donor countries, which was raised during the event, is critical.
- The GDPRD could consider possible mechanisms (e.g., joint funds) to facilitate coordination on particular transformation pathways. [Switzerland]
- Platform members must decide on how to follow-up to the recommendations in the report. One example could be to pilot an initiative of collaborative planning, in particular focus countries. This would be a large undertaking, and approval from the Senior Managers would be needed. [European Commission, Jim Woodhill]
- Donors must attempt to engage with non-traditional donors, the private sector, and partner countries to facilitate further coordination. [The Netherlands]
- The Platform invited the African Union to participate in the event, but did not receive a response, which brings up the possible challenges of working at country and regional levels. However, after the event, several IFAD Regional Directors expressed interest in the follow-up to this work. [Jim Woodhill, Maurizio Navarra]
- The Board must consider the GDPRD's positioning on non-traditional donors. *[Jim Woodhill, France]*

ACTION POINTS:

- An event report, along with the final report of the country-level donor coordination workstream will be produced. Further conversations on aid effectiveness and beyond will be held during the Annual General Assembly (AGA).
- During the coming 2023 Senior Managers Meeting (October) this event and a follow-up to the workstream on country-level coordination will be discussed, to assess whether there is support for actionable ways to bring this conversation forward.
- The Platform and the Board will need to properly formulate guiding questions and options for the Senior Managers, essentially asking whether there is appetite to pilot country-level coordination mechanisms.

2. Summary and updates on innovative financing workstream + Q&A

PURPOSE OF SECTION:

The Shamba Centre presented updates and findings on the finance workstream, which was proposed at the <u>December Board meeting</u>.

ISSUES DISCUSSED:

- The workstream is a stakeholder inquiry into how donors are working to make their funding innovative and catalytic. Thus far, there have been interviews with donors, multilateral development banks, funds, independent experts, and philanthropic organizations. More interviews will take place over the coming months.
- Some of the topics being discussed are:
 - Addressing market failures
 - Opportunity costs
 - Financial and development additionality
 - Can thematic funding on climate, biodiversity, gender, etc. make a larger allocation to food?

- Mobilizing funding from the private sector
- Experimentation of new instruments: funds and pay-for-performance
- Salient points in the business case for patient capital
- Screening of grantees
- Exit strategy for patient capital
- Some findings thus far:
 - Every entity in agriculture and food system value chains must be bankable.
 - Investing in one part of the value chain, without understanding its interactions higher or lower on the value chain leads to more market failures.
 - There is appetite from donors to look at long-term funding with very low returns, but there must be consistent patient technical assistance to build markets and capacities.
 - Donors may need assistance in building contractual relationships between small producers, farmers, SMEs and larger entities.
- Some funds and donors are beginning to look at lending and grants related to performance outcomes; for example, a valuable performance outcome is a contractual relationship with an entity that is higher on the value chain. [Shamba Centre]

ACTION POINTS:

- Board members to provide the Shamba Centre with introductions to their colleagues working on blended finance, and if possible, with the G20 Sustainable Finance working group.

3. Updates on the Annual General Assembly 2023 + Q&A

PURPOSE OF SECTION:

The Secretariat provided an update on the 2023 Annual General Assembly (AGA) and logistical details were discussed.

ISSUES DISCUSSED:

- This year's <u>Annual General Assembly (AGA)</u> coincides with the Platform's 20th anniversary, a milestone reflected in the theme "20 Years of Rural Development and Aid Effectiveness: Where are we now and where are we going?". The AGA will reflect on the Aid Effectiveness Agenda and chart donor directions for the future. The AGA will be held on 26 and 27 October at IFAD HQ and on Zoom.
- The AGA will be built around the themes of balancing emergency responses and longterm sustainability and resilience measures, donor approaches, and stakeholder engagement.
- There will be high-level sessions on the two workstreams (i.e., country-level donor coordination and sustainable finance), and a space/session for each of the three GDPRD working groups.
- The Platform is developing a background paper which will reflect on 20 years of the GDPRD and the Aid Effectiveness Agenda. The paper will help guide conversation of the AGA and is being developed by Brian Baldwin, former IFAD staff and GDPRD Senior Advisor who had been involved in the Platform for a long time, including as Co-Chair.

• It will be a forward-looking paper, considering the Platform's 20 years of experience, which will explore the evolution of principles (the 5 Busan Principles, the Mexico Meeting in 2014 and the Paris Agreement) that have affected the work of donors and the Platform over the past two decades. The background paper will examine past and current issues and discuss how the Platform can best contribute to development agendas. [Brian Baldwin]

- The Platform will reach out to all Board Members via email to mobilize speakers for the AGA.
- The paper will be sent to Board Members before the AGA for review and comments.

4. Platform Co-Chairmanship

PURPOSE OF SECTION:

Announcement that the current Co-Chairmanship of the Platform is ending shortly.

ISSUES DISCUSSED:

- Conrad Rein is leaving the European Commission at the end of July and will thus give up his role of Co-Chair of the GDPRD.
- Australia will continue to Chair the Platform until the end of the year,

PURPOSE OF SECTION
