# **Development Finance for Youth in a Changing Landscape**

### **1. Background**

Amid reductions in development aid and shifting donor priorities, the development community faces increasing pressure to adapt while continuing to serve the needs of its stakeholders. The OECD projects a 9–17% drop in net official development assistance (ODA) in 2025, following a 9% decline in 2024<sup>1</sup>. This projected decline, equivalent to approximately US\$ 35 billion, is largely driven by cuts announced by four major ODA providers: France, Germany, the United Kingdom, and the United States. Long-term trends are equally concerning: between 1990 and 2022, the share of European Commission aid directed to least developed countries (LDCs) fell from 52% to 19%<sup>2</sup>. Even more drastically, 83% of USAID programmes were cut in the first half 2025<sup>3</sup>.

As conflicts intensify and hunger rises, the need for development aid, and its core purpose of alleviating poverty and improving livelihoods, remains undiminished. Youth face critical challenges, especially in Africa, where demographic pressures are high, wage employment opportunities are limited and formal job creation is insufficient in providing access to decent work. Many young people continue to work in low-quality jobs due to weak enforcement of labour standards, leaving them among the working poor.

### **2. Objectives**

This webinar aims to explore how emerging financing mechanisms can contribute to youth employment creation. It will examine the comparative advantage of new financing schemes such as green bonds, green loans, climate funds and carbon credits, with particular attention to their potential impact on youth.
