Alexander Müller

Founder and Managing Director of TMG - Think Tank for Sustainability in Berlin/Germany

Alexander Müller is a sociologist by training. He began his public service as City Councilor for Social and Environmental Affairs in Marburg and later served as a Member of Parliament in Hessen. He held State Secretary roles in Hessen and in Germany's Ministry for Consumer Protection, Food and Agriculture, and was Assistant Director-General of FAO. He led key UN food security summits, chaired the United Nations System Standing Committee on Nutrition, advised the UN Secretary-General on energy and climate, and directed the TEEBAgriFood initiative on the "The Economics of Ecosystems and Biodiversity Agriculture and Food".

Leonard Mizzi is Head of Unit at the European Commission's DG International Partnerships, leading work on Sustainable Agri-Food Systems and Fisheries since 2017. He previously spent ten years at DG Agriculture and Rural Development, managing agri-trade, development and interinstitutional relations. He holds degrees from the University of Malta, CIHEAM-Montpellier (MSc) and the University of Reading (PhD in Agricultural Economics). Formerly Director of the Malta Business Bureau in Brussels, he has broad experience in Malta's public and private sectors. A frequent lecturer at the College of Europe, his expertise includes global food security governance and agriculture in the Mediterranean and Sub-Saharan Africa.





Max von Bonsdorff

Max von Bonsdorff is the chief partnership officer in IFAD's Global Engagement, Partnership and Resource Mobilization Division. In this capacity von Bonsdorff leads GPR's team that designs, implements and supports IFAD's resource mobilisation efforts, covering issues such as replenishment, borrowing and supplementary funding processes. Von Bonsdorff joined IFAD in August 2020 from the Ministry for Foreign Affairs (MFA) of Finland in Helsinki, where he worked as Director of the Unit for Development Finance and Private Sector Cooperation. Between 2004-2016 he held various positions in MFA Finland, such as economic and results management adviser. In 2007-2011, Von Bonsdorff worked as Head of Cooperation at the Embassy of Finland in Vietnam. In 2011-2014 he worked as an Executive Director's adviser in the Asian Development Bank.

Maximo Torero Cullen

Chief Economist, Food and Agriculture Organization of the United Nations (FAO)

As FAO's Chief Economist, Maximo Torero leads FAO's work with governments and partners to build resilient, inclusive, and sustainable agrifood systems. He focuses on strengthening shock resilience, advancing innovative financing, improving access to healthy diets, and reinforcing supply chains. His work is grounded in decades of research on commodity prices, market volatility, and their effects on poverty and hunger. Torero directs FAO's economic policy engagement in global SDG processes, especially Zero Hunger, and serves as the organization's analytical voice at high-level forums. He also provides intellectual leadership for FAO's flagship reports, including The State of Food Security and Nutrition in the World.

Lawrence Haddad

Executive Director, Global Alliance for Improved Nutrition (GAIN)

Lawrence Haddad has been GAIN's Executive Director since 2016. In 2020 he was asked by the UN Deputy Secretary General to Chair Action Track 1 of the 2021 <u>United Nations Food Systems Summit</u>: Ensuring Access to Safe and Nutritious Food for All. Lawrence is the co-founder of the <u>Standing Together for Nutrition</u>, a response to the COVID-19 crisis, and is one of the drivers behind the Initiative on Climate and Nutrition (<u>ICAN</u>) which was formally launched by the Egyptian Government at COP27. Prior to GAIN, Lawrence was lead author of the Global Nutrition Report, Director of the Institute of Development Studies (IDS), and Director of the Food Consumption and Nutrition Division at IFPRI. He was made a World Food Prize Laureate in 2018 and was awarded a CMG in the 2023 UK Honours List for his "services to international nutrition, food and agriculture". Click <u>here</u> for more.

Alice Ruhweza is a global thought leader and international development expert with nearly 30 years of experience in social, economic, and environmental policy. She is the President of <u>AGRA</u>, where she leads efforts to transform agrifood systems for sustainable development in Africa and globally.

Previously, Alice was Senior Director for Global Policy at WWF International, influencing sustainability agendas across Africa, Asia, and Europe. As WWF's Africa Region Director, she oversaw operations in 13 countries. She also served as Vice President at Conservation International, where she bridged science and policy for sustainable agriculture. Alice led the UNDP's Global Environmental Finance Unit, mobilizing over US\$1 billion for sustainable development across 44 countries. She holds degrees in Economics and certifications from Harvard, IMD, and Oxford.

Alice co-chairs the World Economic Forum's Global Future Council on Nature and Security and serves as an advisory member of the Strategic Foresight Group, among others.

Stefania Lenoci

World Bank Group Resident Representative to Italy

Stefania Lenoci is the World Bank Group Resident Representative in Italy and Special Representative for Southern Europe, the Holy See and the United Nations Agencies in Rome. In this role, she leads the World Bank Group's engagement with Southern European institutions and partners, international organizations, private sector and the Holy See, fostering strategic partnerships, policy dialogue, and collaboration on global development priorities.

Prior to joining the World Bank, Stefania served as the Head of the Private Sector Advisory and Implementation Unit (PAI) at the International Fund for Agricultural Development (IFAD) from 2020 to 2024. In this capacity, she spearheaded IFAD's direct investments in the private sector to drive inclusive and sustainable agricultural investments, ensuring the effective implementation of IFAD's Private Sector Engagement Strategy. The PAI, established in 2019, played a central role in mobilizing private-sector partnerships and investments to enhance rural development and food security.

Before leading PAI, Stefania was Senior Adviser to the President of IFAD (2017-2020), where she contributed to shaping IFAD's strategic priorities and institutional partnerships. She previously served as Adviser to the Vice-President of IFAD, Partnership Officer in the Partnership and Resource Mobilization Office (2012-2017), and Governing Bodies Officer in the Office of the Secretary (2010-2012).

Before joining IFAD, Stefania worked as a Programme Specialist in the Conflict and Post-Conflict Coordination Unit at UNESCO in Paris (2004-2010), focusing on education, culture and development programs in fragile contexts. She began her career at the United Nations Development Programme (UNDP) in Rabat (2003).

Stefania holds an MSc in Sustainable Development from the School of Oriental and African Studies (SOAS), University of London, and a BA in International and Diplomatic Sciences from the University of Trieste.

Nikita Eriksen-Hamel is Deputy Director of Food Systems Practice in the Food Systems and Nutrition Division of Global Affairs Canada. He leads a team of policy analysts and technical specialists who provide strategic, policy and technical advice to the Department's agri-food systems and nutrition programs and leads Canada's engagement in many multilateral and global policy fora. Prof. Anas A. Al-Nabulsi, Dean of Agriculture at Jordan University of Science and Technology, is an expert in food microbiology and safety. He has driven reforms in agricultural education by integrating Al and IoT to promote sustainability and food security. Under his leadership, programs achieved international accreditation, and he directed and contributed to research funded by USAID, WFP, IFAD, and ERASMUS+ on food safety systems, traceability, and capacity building. His work spans strategic foresight on Jordan's food system, policy briefs on malnutrition and water conservation, and evaluation of school feeding programmes. He has also contributed to national regulatory frameworks and committees on agriculture and food security.



Clara Pacheco

Clara Albergaria Pacheco has been Head of the Food Security, Nutrition and Sustainable Agriculture Unit at the French Ministry of Foreign Affairs since March 2024. She was Deputy Head of the Third Countries Export Unit (2009-2018), Deputy Head of the Plant Health Unit (2007-2008), represented France as an expert at



the International Plant Protection Convention, the European and Mediterranean Plant Protection Organisation and the European Commission.

She holds a Master's degree on Phytopathology from the University Paris-Saclay and an Agronomist Engineering degree from the University of Lisbon.



Sandra Bartelt

Principal Adviser for G7 and G20 Sustainable Development Agendas
Directorate-General for International Partnerships, European Commission

Sandra Bartelt provides strategic guidance to the Director-General on the sustainable development dimensions of the G7 and G20 processes, shaping the EU's policy input to leaders' and ministerial meetings since May 2024. She joined the European Commission in 2004 in the Secretariat-General, contributing to crossinstitutional coordination on major policy files. In 2011, she moved to the Legal Service's external relations team, where she advanced legal positions on development cooperation, the Common Foreign and Security Policy, and innovative financing. She represented the Commission before the General Court, the Court of Justice, and in arbitration proceedings.

In 2017, she became Head of Unit for Legal Affairs in DG INTPA, overseeing regulatory compliance and supporting the formulation of EU external action instruments. From 2019 to 2024, she served as Deputy Head of Cabinet to the Commissioner for International Partnerships, steering political priorities and legislative initiatives. Before joining the Commission, she worked at the German Federal Foreign Office on security policy, counter-terrorism, and sanctions implementation. She studied law in Germany and in the U.K. She earned a PhD in public international law from the University of Cologne, focusing on the EU's operational capacity in security and defence. She holds an LL.M. in European Law from the College of Europe in Bruges. Her expertise spans multilateral governance, sustainable development, and EU external relations. She brings extensive experience in high-level negotiations and institutional coordination. Dr. Bartelt contributes to strengthening the EU's global role through evidence-based policy and legal stewardship.
